1. Protocol: Exacto.
2. Ratings: WC 4-7, 10-14, and 20-24 DAT.
3. ERICA-HR = Herbicide-resistant marestail (glyphosate).
 AMASS = Amaranth species including AMATA (common waterhemp) and AMARE (redroot pigweed).
4. Blanket burndown application of glyphosate (1.13 lbae/A) plus NIS (0.5% v/v) plus AMS solution (5% v/v) was applied 4-19-10.
5. Not harvested.
